Application for childcare contributions

Please note that you must submit the complete application with all the necessary documents at least one month before your child enters the childcare center.

Childcare contributions are granted from the beginning or middle of the month following the month in which the complete application was submitted. Childcare contributions aren't granted retroactively.

6. Application for basic childcare contribution

All families pay a maximum of CHF 1,600 per full-time place per month – regardless of income and assets. All families receive a basic childcare contribution. We calculate this basic contribution without taking your income and assets into account. You do not have to provide us with any information about your income and assets.

→ We need an employment contract or a confirmation from your employer stating your working hours in percentage, valid upon date of entry in the daycare center.

In order to receive the basic contribution, you must meet every entitlement for childcare contributions.

7. Information on income and assets

The childcare contribution depends on the parents' income and assets. The basis for the calculation is the last tax assessment of the Canton of Basel-Stadt. We are authorized to inspect these in accordance with the «Gesetzes über die Harmonisierung und Koordination von bedarfsabhängigen Sozialleistungen vom 25. Juni 2008 (SoHaG, SG 890.700)».

8. Reporting Obligation, Confirmation and Signature

You must report any significant changes to your entitlement to childcare contributions or to your income or assets. This includes, for example, a change in household or marital status (e.g. separation or divorce), a change in family circumstances (e.g. birth of a child) or a change in work or training hours. If your annual income and assets change by at least 20% for more than three months, you must also notify us. The notification must be made no later than one month after you become aware of the change.

9. Documents

To confirm your entitlement to childcare contributions, we may need certain documents:

If you are in education or training:

Proof of education or training

If you are job hunting or registered with the regional employment center (RAV):

Last statement of daily allowances

If you receive social welfare:

Last statement of daily allowances

In case of employment:

- > Employment contract
- Or confirmation from your employer stating your working hours in percentage, valid upon date of entry in the daycare center
- if your child is younger than 12 months when entering the daycare: agreement on parental leave with the employer regarding the return to the workplace

If you do not have a tax assessment from the Canton of Basel-Stadt, we will calculate your income and assets ourselves. We need certain documents for this:

- Proof of education for children in education
- > Receipts for non-taxable support

Income

- > Annual salary statement from the previous year
- Pay slips for the last three months
- Employment contract

Self-employed persons

Business balance sheet and income statement for the last two years

Alimony, maintenance payments (received or paid)

- Divorce decree and proof of payment (divorced parents)
- Separation decree and proof of payment (separated, married parents)
- > Order from the child protection authority or proof of payment (unmarried parents not living together)

Other income

Orders or proof of payment for all other income such as pensions, daily allowances, grants, etc.

Assets

- Proof of assets for assets over CHF 37,500 for single parents, CHF 60,000 for couples, plus CHF 15,000 per child (e.g. tax assessment from the previous canton of residence, annual bank account statement)
- Proof of income from assets (for asset income of more than CHF 500 per year)
