The undersigned person also confirms having read and understood the declaration on residence in Switzerland.

Declaration on residence in Switzerland

The place of residence is the place in which a person resides with the intention of staying permanently and where the centre of their life is based. It is where the focus of family, social and private relations lies. Swiss law¹ only allows for one place of residence, which means that the centre of a person's life cannot be based in several places at the same time. With the registration in accordance with the law on residents, it is also confirmed at the same time that the place of residence or centre of life is exclusively in the canton of Basel-Stadt. If the Migration Office of Basel-Stadt becomes aware of another place of residence in a foreign municipality, this may lead to the expiry of the right of residence in Switzerland.

You have the right, vis-a-vis the body responsible, to access your personal data, to have inaccurate personal data corrected or deleted, the consequences of the unlawful processing of personal data rectified, the issue of a written statement that personal data has been unlawfully processed, you can also send a regulatory notification to the Cantonal Data Protection Officer or Cantonal Data Protection Officer.
